Wesdome Gold Mines has had over 30 years of continuous gold mining operations in Canada. The Company is 100% Canadian focused with a pipeline of projects in various stages of development. The Company's strategy is to build Canada's next intermediate gold producer, producing 200,000+ ounces from two mines in Ontario and Quebec. The Eagle River Complex in Wawa, Ontario is currently producing gold the Eagle River Underground Mine. Wesdome started production in December 2022 at the Kiena Complex in Val d'Or, Quebec. The Company trades on the Toronto Stock Exchange under the symbol "WDO".

SUMMARY

The over-time eligible position reports to and works under the direction and management of the Site Lead for Environment and will coordinate closely with other teams on and off-site including staff and leadership at the Eagle River mine. In accordance with Company protocols and policies, the Lead, Environment Projects and Permitting will manage existing and future environmental projects including compliance and permitting, as well as innovations and strategies for continuous improvement on environmental stewardship and performance. The role will include strategizing, compliance and technical reporting writing, visible felt leadership, environmental monitoring and project management. This role will also be occasionally responsible for community outreach and public presentations.
